Terms & Conditions

These Terms & Conditions are entered into between the User (hereinafter referred to as "User", "you" or "your"), the Crona Fund RAIF V.C.I.C. PLC (hereinafter "the Crona Fund") and Eleon Capital Management Ltd (hereinafter "ECM") as the administrator of the Website and Alternative Investment Fund Manager of the Crona Fund.

By accessing or using this Website, you agree that you have read, understood and accepted the Terms and Conditions included in these Terms & Conditions as well as the Privacy Policy. If you do not agree with the present Terms & Conditions, you should not use the Website.

By using this Website, you acknowledge and agree that you are aware of the risks associated with any investment referred to on this Website, including the risk of losing your entire invested capital.
